PROTECTION

All Substrates Should Be Structurally Sound, Stable , Dry, Clean And Free Of Any Substance Or Condition That May Reduce Or Prevent Proper Adhesion.

Protect from traffic for 24 to 48 hours. Protect from heavy traffic for 7 Days.

Protect from humidity and rain for 7 days.

Glass mosaic tile required at least 21 days of curing time after grouting before filling water in the pool.

SURFACE PREPARATION

- Clean the surface thoroughly as it should be free fro dust, dirt, oil grease etc.
- For good coverage ensure that the new plaster should be flat enough for levelling finish.
- All tiles and other porous or non- porous surface should be cleaned & washed with clean water.
